

PIZZA 73 “CUSTOMER SATISFACTION SURVEY” SWEEPSTAKES OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. MAKING A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING.

SWEEPSTAKES ENTRY PERIOD: The **Pizza 73 Customer Satisfaction Survey Sweepstakes** (the “Sweepstakes”) begins at 12:00:01 AM Eastern Time (“ET”) June 1, 2021 and ends at 11:59:59 PM ET on December 31, 2021 (the “Sweepstakes Period”). Sponsor’s computer is the official clock for this Sweepstakes.

ELIGIBILITY: The Pizza 73 Customer Satisfaction Survey Sweepstakes is only open to legal residents of the provinces of Alberta, British Columbia, Saskatchewan and the Yukon Territory in Canada and those who are the age of majority in the province/territory in which they reside at the time of entry (“Entrant”). Void outside these geographic areas and where prohibited or restricted by law. Employees of Pizza 73 (“Pizza 73” or the “Sponsor”) and its advertising/promotional agencies and their parents, members, affiliates, subsidiaries and agencies, and their immediate family members (spouse, parents, children and siblings, and their respective spouses) and persons living in the household of each (whether related or not) are not eligible to participate. All federal, provincial and local laws and regulations apply. Participation constitutes Entrant’s full and unconditional agreement to these Official Rules and to Sponsor’s decisions, which decisions shall be final and binding on all persons as to all matters related to the Sweepstakes. Winning a prize is contingent upon the entrant fulfilling all requirements set forth in these Official Rules.

ENTRY: There are three (3) ways to enter.

Method #1: Receipt Invite - To enter, Entrants must enter the required information located on the bottom of your specially marked Pizza 73 receipt received from the participating Pizza 73 locations (the “Receipt Information”), at pizza73survey.ca and answer any required guest satisfaction survey questions including Entrant’s contact information. Entrants must follow online instructions at the designated website for entering Receipt Information. When the Receipt Information has been successfully entered and accepted (Receipt Information must be entered exactly as they appear or they may not be accepted), Entrants will be invited to complete a survey. The answers to the survey will have no effect on an Entrant’s ability to enter or win. Upon completion of the survey, the Entrant will be invited to complete the Sweepstakes entry form in its entirety and submit to receive one (1) Sweepstakes entry (the “Survey Entry”) during the Survey Period (as defined below) in which the entry is received. Each Receipt Information may only be entered one (1) time during the Sweepstakes Period and cannot be reused. All information received becomes the property of the Sponsor, and will not be sold to any third party. Proof of entry does not constitute proof of submission. All Receipt Information is subject to verification. Online Entrants are subject to all notices posted online including but not limited to the Sponsor’s Privacy Policy. There is no limit to the number of receipt invite entries an Entrant can receive during the Sweepstakes Period.

Method #2: Email Invite - To enter using this method, Entrants must be the recipient of an email receipt invitation, which will have instructions inviting Entrant to click the link to be taken to the survey page, to complete the survey, and upon completion of the survey Entrant will automatically

receive one (1) Sweepstakes entry in the Sweepstakes (the “Survey Entry”) during the Survey Period in which the entry is received. All information received becomes the property of the Sponsor, and will not be sold to any third party. Proof of entry does not constitute proof of submission. Online Entrants are subject to all notices posted online including but not limited to the Sponsor’s Privacy Policy. There is no limit to the number of email receipt invite entries an Entrant can receive during the Sweepstakes Period.

Method #3: Mail-in Invite- To enter the Sweepstakes without purchase, hand print your full name, mailing address, telephone number, and email address on a plain piece of paper and mail it in a stamped envelope to: PIZZA 73 Customer Satisfaction Survey Sweepstakes: 13703 164 Street NW, Edmonton, Alberta, T5V 0C8 during the Sweepstakes Period. Upon receipt and verification by Sponsor, you will receive one (1) mail-in entry into the applicable Survey Period for which the mail-in entry was post-marked. Each mail-in entry must be in a separate stamped outer envelope post-marked on the date of entry (or the following business day, if applicable). Only original, hand-printed mail-in entries will be eligible; no photocopies or other reproductions. There is no limit to the number of mail-in entries an Entrant can submit during the Sweepstakes Period.

Limit: One (1) entry per Entrant per day regardless of methods of entry. If more than one entry is received from the same person or email address on the same day, all but the first entry will be disqualified. Any attempt to enter the Sweepstakes other than as directed in these Official Rules will be invalid and void. All methods of entry have an equal chance of winning.

SURVEY PERIODS: There are nine (9) Survey Periods as defined in the chart below (“Survey Period”). Entries must be received during the Survey Period to be eligible for that Survey Period drawing. Non-winning Survey Period entries will not be rolled over to subsequent Survey Periods.

RANDOM DRAWING: One (1) potential Grand Prize winner will be selected each Survey Period during the Sweepstakes Period in a random drawing from among all eligible entries received for that Survey Period. The drawing for each Survey Period will be held in accordance with the chart above.

WINNER NOTIFICATION:

Potential Grand Prize winners will be notified via email and/or phone, and will be required to correctly answer a skill-based mathematical test question without mechanical or other aid (which

may, in the sole and absolute discretion of the Sponsor, be administered online, by email or other electronic means, by telephone, or in the Sponsor's form of Declaration and Release) within a limited time-period in order to be eligible to receive his or her prize. Not providing the answer within the required time period, providing an incorrect or incomplete answer, or noncompliance with the terms of administration of the skill-testing question will result in disqualification of the potential winner and an alternate winner may be selected. Without limiting the generality of the forgoing, the Sponsor reserves the right, in its sole and absolute discretion, to administer an alternate test of skill as it deems appropriate based on the circumstances and/or to comply with applicable law. Noncompliance will result in disqualification and an alternate winner may be selected. Prize will be awarded within approximately 15 days after the winner is verified

If winner notification is returned as undeliverable or if a selected winner cannot accept or receive the prize for any reason, or he/she is not in compliance with these Official Rules, the prize will be forfeited and an alternate winner may be selected in a separate random drawing.

PRIZE/APPROXIMATE RETAIL VALUE ("ARV")/ODDS:

Grand Prize: There are a total of nine (9) Grand Prizes available to be won during the Sweepstakes Period. One (1) Grand Prize will be available to be won each Survey Period during the Sweepstakes Period. Grand Prize is for a \$100.00 CAD Pizza 73 Gift Card (ARV \$100.00 CAD). Total value of all Grand Prizes per Survey Period is \$100.00 CAD.

Total value of all prizes available to be won: \$900.00 CAD. Limit: One (1) prize per person/household during the Sweepstakes Period.

Odds of winning a Grand Prize will depend upon the total number of eligible entries received for each Survey Period.

PRIZE CONDITIONS: Prizes are non-assignable or transferable. No substitution is permitted except if prize is unavailable, in which case a prize of equal or greater value will be awarded. No exchange or substitution of prizes, except at the sole discretion of the Sponsor. Any other incidental expenses associated with the receipt and/or use of prize is the winner's sole responsibility.

Gift cards are not redeemable for cash and will not be replaced if lost or stolen. Gift card usage is subject to the issuing company's complete terms and conditions, including expiration dates.
